4 APPLICATION

The numbering of the articles in this chapter is identical to the numbering of the articles of the standard ETSI EN 319 403-1 V2.3.1 (hereinafter „standard“).

Chapter 1 Scope – all requirements apply.

Chapter 2 References– all requirements apply.

Chapter 3 Definition of terms, symbols and abbreviations – all requirements apply.

Chapter 4 General requirements – all requirements apply.

Chapter 5 Structural requirements – all requirements apply.

Chapter 6 Resource requirements – all requirements apply except:

Clause 6.2.1.4: Last sentence **may be replaced** by the following requirement:

Minimum requirements for qualification for auditors performing audits of TSP are: „Auditor with valid international or Slovak certificate of Information System Auditor of ISO 27001. Additionally, auditor must declare authorized evidence of minimum 5 years’ experience in audits of information systems for a total period of at least 20 days, as evidenced by authorized references.

Clause 6.2.1.5 is modified as follows:

"Certification body staff performing the review of the information and the results of the evaluation must be competent within the meaning of Article 6.1.2.4 and have at least three full ISMS audits performed as auditors."

Clause 6.2.1.9:

All requirements apply except of requirement stated in letter a): "participated as an auditor in at least three full TSP audits". Requirement a) **is not applied**. It is **replaced** by a new requirement stated in clause 6.2.1.4.

Chapter 7 Process requirements – all requirements 7.1 to 7.13 apply, whereas cl. 7.4.2 and 7.4.4.5 **are supplemented** as follows:

Additionally, after last sentence of **clause 7.4.2** add sentence:

Time of audit shall be of minimum required time for accordingly to ISMS audits relevant requirements according to ISO/IEC 27006.

Additionally, after last sentence of **clause 7.4.4.5** add sentence:

The audit report must contain sufficient information to enable the supervisor to proceed further in assessing whether the criteria for qualified status (including the form) are met.

Chapter 8 Management system requirements – all requirements apply.
