

#### 1 Introduction

This methodical guideline defines the scope and the scope specification of accreditation of greenhouse gas emission verifiers (further on only "V") according to EN ISO/IEC 17029: 2019, EN ISO 14065: 2021 and Commission Implementing Regulation (EU) 2018/2067, as amended by Commission Implementing Regulation (EU) 2020/2084, obligatory for employees of an accreditation body and applicants for accreditation.

#### 4 SCOPE AND SCOPE SPECIFICATION OF ACCREDITATION

#### SCOPE OF ACCREDITATION 4.1

The scope of accreditation is a general definition of activities of an organization, accredited or seeking accreditation for.

The scope of accreditation of V represents the performance of verification of greenhouse gas emission reports, tonne-kilometre reports and activity level reports according to Act No. 414/2012 Coll. on trading with emission quotas and on amendments to certain laws, Commission Implementing Regulation (EU) 2018/2066 on the monitoring and reporting of greenhouse gas emissions pursuant to Directive 2003/87/EC of the European Parliament and of the Council and amending Commission Regulation (EU) No 601/2012, as amended by Commission Implementing Regulation (EU) 2020/2085 amending and correcting Implementing Regulation (EU) 2018/2066 on the monitoring and reporting of greenhouse gas emissions pursuant to Directive 2003/87/EC of the European Parliament and of the Council. The characteristics of the scope of accreditation will also be laid down in the accreditation

certificate.



# **4.2** SCOPE SPECIFICATION OF ACCREDITATION/SPECIFICATION OF ACTIVITIES

The scope specification of accreditation is a detailed description of activities for the performance of which an organization is accredited.

The specification of activities is a range of activities for which an organization seeks accreditation and which in form is identical with the scope specification of accreditation.

The scope specification of accreditation is laid down in the application for accreditation and it will also be laid down in the annex to the accreditation certificate.

The scope specification of accreditation of V is defined in accordance with Annex I to Commission Implementing Regulation (EU) 2018/2067, as amended by Commission Implementing Regulation (EU) 2020/2084.

For the activity group No 98 the accreditation can be granted only in conjunction with at least 1 activity group 1-9 or 12.

The scope specification of accreditation of V is expressed as a table consisting of all activities for which the V may be accredited and is given in the following table.
