SNAS technical committees are established as advisory bodies to the SNAS Director for attestation of competence of assessors and experts in the concerned fields of accreditation and for addressing technical and methodological issues in SNAS's fields of accreditation to make sure all technical and specialized problems and relevant documents are discussed and resolved in SNAS in the required technical standard. For these purposes SNAS uses expertise from external resources (top specialists and experts in the areas of research, development and technical practice, universities and institutions of higher education in SR as well as experienced experts from accredited organizations).

## 5 STATUTE OF SNAS TECHNICAL COMMITTEES

### 5.1 SCOPE OF TV

The mission of the SNAS Technical Committees is contributing the development of accreditation in the areas of laboratories, proficiency testing providers , inspection bodies, certification bodies, environmental verifiers and greenhouse gas emissions verifiers.

### 5.2 KEY TASKS OF TV

- a) Give opinions of SNAS plans to extend its activities by accreditation in a new technological area or a new sectoral scheme or, if relevant, introduction of a new conformity assessment activity.
- b) In the instance of introduction of accreditation in a new technical area, assist SNAS in handling all related technical issues through:
  - Actively participation in preparation of technical documents for the needs of accreditation,

- Proposing candidates for assessors and experts for the concerned area from among competent experts in the area,
  - Trainings for SNAS assessors and experts for accreditation in the new technical area,
  - Assessing SNAS's preparedness for accreditation in a new technical area or, if relevant, SNAS's preparedness for accreditation of a new conformity assessment activity.
- c) Attest the competencies of SNAS (TL 120) assessors and experts for the concerned area through assessment by the relevant TV unless that committee has appointed working groups or assessed the relevance and objectiveness of the supplied references and documents concerning their competence in the concerned accreditation area from specialized companies, associations/specialists in the concerned area/acknowledged commissions and the like,

### 5.3 COMPOSITION OF TV

The stakeholders of technical committees include leading external experts in practical areas close to the concerned accreditation area, e.g. education, health, government, science and research, CAB and users of CAB results, professional associations. These experts provide the required guarantee to SNAS that the adopted decisions and drafted technical documents meet the required qualifications and take account of the knowledge, experience and needs of contemporary technical practice. They appoint working groups for specific activities related to narrow specializations (See Chapter 7).

A technical committee operates with the following composition:

- a) TV chair,
- b) TV members,
- c) Secretary (not a TV member).

The position of TV chair is generally performed by technical guarantees or heads of relevant departments; the office of secretary is generally performed by manager of human resources unless decided otherwise by the SNAS Director. If needed, the chair can authorize one of the technical guarantees or heads of relevant departments OLIS or OCO to preside over a specific meeting.

The Chair may, if necessary, invite other experts from the consideration area.

The TV members are appointed and withdrawn by the SNAS Director upon proposal from a relevant head of TV (TL 602).

## 6 RULES OF PROCEDURE FOR SNAS TECHNICAL COMMITTEES

### 6.1 RIGHTS AND RESPONSIBILITIES OF TV MEMBERS

#### TV chair:

- Prepares the program for deliberations,
- Sets the way of the meeting, , date for the meeting and manages its course in line with the TV's scope and mission,
- Is responsible for the TV's activities,
- Approves the minutes of TV meetings.

#### TV members:

- Has the right to give opinions on all discussed issues related to the area of accreditation within the scope of the concerned TV,
- Are obliged to attend the TV meetings and participate in accomplishment of its tasks through his or her expert knowledge and experience,
- Are obliged to submit a written opinion on the discussed issue to the SNAS Director if requested,
- Are obliged to observe confidentiality over facts related to the discussed issues, if relevant,
- Are obliged to perform impartially and independently their tasks related to SNAS activities,
- Are obliged to notify in advance for absence from TV deliberations.

#### TV secretary:

- Is not a TV member,
- Produces the draft minutes of the TV meeting and submits it for approval to the TV chair,
- ensures the transfer of information to the human resources database in AIS

#### Administrator in the Secretariat

- Is not a TV member,
- Takes care of organizational, technical and administrative activities to ensure the activities and preparation of the TV and the course of TV meetings.

### 6.2 DELIBERATIONS OF TV

- a) The organizational aspects of a TV are taken care of by the TV secretary upon an instruction from the TV chair;
- b) Invitations to and the program of the deliberations or other supporting materials for TV deliberations are sent by the TV secretary at least 7 days before the scheduled meeting date;

- c) The TV meeting is managed by the chair and in his/her absence another member authorized by the chair.
- d) The TV chair may decide to invite, if deemed appropriate for the scheduled agenda, other external collaborators for specific accreditation areas and technical guarantees for the concerned accreditation areas within SNAS.
- e) TV has a quorum when an absolute majority of ordinary members are present. Connection via teleconference, videoconference or written opinion on the deliberations of the program is deemed to be present at the meeting.
- f) Minutes are produced from the TV deliberations in the AIS and include the TV's recommendations, positions and conclusions on the discussed issues.
- g) Once the minutes have been prepared, the secretary sends them to all members who were present at the TV meeting and they have the right to give their opinion of the minutes within 10 days following its delivery and to notify the TV chair. If there are differing positions to the adopted conclusions, the minutes shall include also individual positions formulated by a member(s) upon request.
- h) The minutes of the TV meeting, following the comments-giving by members, are approved by the TV chair and the TV secretary sends the agreed and approved version to all TV members and enters it in the ADMIS.
- i) The meeting is convened as needed, usually at least once a year.

## **7 TV WORKING GROUPS**

### **7.1 MISSION OF WG**

SNAS technical committees that cover a broad array of specializations under an accreditation area (testing, certification), not only may have in addition to the appointed TV member (s) also „ad hoc“ members of working groups (WG) to work more effectively within the narrower specialization of the accreditation area.

### **7.2 KEY TASKS OF WG INCLUDE:**

- Competent and effective assessment of the competence of SNAS assessors and experts for the concerned assessment area,
- Assessing the relevance of the submitted references, documents and evidence from technical associations/commissions/specialists in the area related to their professional competence in the specific accreditation area, if the WG is requested to do so,
- Propose candidates for assessor and expert position for specific accreditation areas,
- Assist, if needed, in preparation of specialized documents for the needs of accreditation,
- Provide, if needed, operational positions to issues of concern in specific accreditation areas.

### 7.3 COMPOSITION OF WG

Working group members include leading external specialists in specific accreditation areas. A working group operates with the following composition:

- a) WG head (TV chairmen or member TV delegated by him),
- b) WG members,

The office of WG head is performed generally by TV chairmen. The WG members are TV members and optionally external experts competent to cover the concerned specific areas. The WG must have at least three regular TV members. The Chairman may, if necessary, invite other relevant experts.

### 7.4 DELIBERATIONS OF WG

- a) Deliberations of a WG are called as needed and managed by the WG head. A WG meeting can be held also in electronic form (the so-called correspondence deliberations);
- b) The WG head can be substituted if needed by the him authorized officer of SNAS..
- c) The WG head can decide to invite/approach more external experts for specific areas if it is useful for the matter to be discussed.
- d) A WG has a quorum if at least three of its full TV members are present and the same holds for correspondence deliberations.
- e) Minutes are produced from the meeting in which the WG's recommendations, positions and conclusions on the discussed matters are drafted. The minutes are produced by the WG head;
- f) Every WG member can give an opinion on the minutes.
- g) Following the comment-giving by the WG members to the minutes, the minutes then are submitted to the WG head for approval and entered into ADMIS.

## 8 REMUNERATION OF EXTERNAL MEMBERS OF TV, WG TV

For the individual participation in one meeting, each external TV and WG TV member is entitled to the time spent on the negotiation and the study of the documentation being discussed for the payment of the amount under the valid RR-03 document. If the external TV or WG TV member notified of absence from a deliberation and submitted an opinion on the discussed documents in electronic form, he/she is entitled to 50% reimbursement.
